Abate all lead as listed in assessment. Remove all windows and window frames. Cover all openings with OSB or plywood. Do not damage blue metal siding. Remove door and frame at front entrance. Note* Radon Sub	Radon piping <u>not</u> to be in the sump basket.
	 Install an active radon system to include a 3" schedule 40 pipe running from below the concrete slab up and out the basement rim to the exterior. Radon fan will be on the exterior of the home. In the basement, break through the concrete floor and dig out enough dirt to create a void approximately 20" in diameter. The pipe is to be set at the bottom of the slab rather than the bottom of the hole and should be T'ed to run 3" in two directions. The hole is to be sealed with foam-rubber backer rod and patch concrete around base of the pipe. The pipe run should have as few horizontal sections and elbows as possible. This work is also to include the installation of the manometer.
