This year, **10,206 individual volunteers contributed a total of 148,674 volunteer hours** and **8,626 donors** generously gave **\$19,675,035** in financial contributions and **\$1,353,023** in gifts in-kind.

In addition to the thousands of individuals who support Habitat, many organizational donors—like corporations, faith communities, and foundations—have given in the past year. You can see them listed in this book.

Twin Cities Habitat for Humanity is thankful for this broad community working together toward an equitable Twin Cities region where all families have access to the transformational power of homeownership.

## Individuals

Instead of listing individual donor names, we are highlighting the broad community of Twin Cities Habitat for Humanity supporters and the many ways you help make the mission happen.

**10,206 individual volunteers worked a total of 148,674 volunteer hours.** That time is valued at more than **\$4.6 million** according to the Independent Sector value of volunteer hours in MN!

**2,246 donors** made their first gift to Twin Cities Habitat, joining a collective total of **8,626 donors** committed to building the quality of life, health, and economic prosperity of our community through affordable homeownership.

**73 sponsors** made contributions to kickstart **30 homes** at The Heights for the 2024 Jimmy & Rosalynn Carter Work Project. **2,252 enthusiastic volunteers** representing **38 states** contributed a collective **27,749 hours** to build homes, provide hospitality, and support events during this milestone week.

Launched **Volunteer & Learn** program to engage homebuyers and homeowners in our work. Offered eight volunteer opportunities in this new client-centered program, including Skill Build events, Learn Together events, and Build Community events.

As the Twin Cities area continues to grow, securing land for Habitat home projects becomes more challenging. **Five individual and organizational donors made gifts of real estate** to Twin Cities Habitat, creating a lasting impact for families through Habitat homeownership.

With help from **Youth Ambassadors** and guidance from the **Leadership Council**, we hosted the third **Family Volunteer Day** and welcomed dozens of families to the Habitat office for fun-filled activities while learning about Habitat.

**44 AmeriCorps members** contributed a total of **19,140 hours**, serving as leaders on homebuilding sites and in-office roles assisting clients, volunteers, and staff.

Thank you to the **977 Builder’s Circle members**. This group of individuals and family foundations build a brighter future for families and transform communities with **annual gifts of \$1,000 or more**.

Celebrated the “retirement” of **five long-time regular volunteers** who were now welcomed into our **Regular Crew Emeritus Group**. Each of these volunteers had given **over 1,000 hours** of their time to our organization over the course of several years, some as many as three decades.

Nearly **1,000 Habitat supporters** attended our **Hard Hat & Black Tie Gala**, and together they raised more than **\$1 million** to support local families.

**Habitat on the Hill** returned to the Minnesota State Capitol, with **112 attendees from 12 Habitat affiliates** across the state meeting with **110 Minnesota legislators** to advocate for affordable homeownership.

Thank you to the **121 Legacy Circle Members**. These generous donors have **included Habitat in their will or estate plans**, building an enduring impact through homeownership.

At our **two ReStore Home Improvement Outlets**, **57 regular volunteers** helped to turn **19,956 donations** from individuals and businesses into sales to support Twin Cities Habitat’s mission.

**43 Women Build Team Leaders** brought their friends

and family out to build with them, coming together on the homebuilding site to learn new skills, form community, and create affordable housing.

Thank you to the **274 Carpenter's Club members**. This group of recurring monthly givers allows Habitat to more adequately budget and plan for the continuous need for affordable housing.

**Four individuals and families** stepped up to be the Major Sponsor of a Habitat house, making significant commitments to Habitat with the opportunity to see their generosity in action.

**290 vehicles** were donated to Twin Cities Habitat's **Cars for Homes** program, where proceeds from those vehicle sales will fuel Habitat's mission.
