



## Support Housing for Minnesotans and Qualify for a Tax Credit

The new State Housing Tax Credit Program and Contribution Fund allows taxpayers to invest in affordable housing across the state. When you contribute, you support housing for all Minnesotans and qualify to receive a state tax credit certificate (TCC) of 85% of your contribution! You can also designate your contribution to support qualifying projects developed by nonprofits like Twin Cities Habitat for Humanity.

- **Who can contribute?**

Individuals and businesses that pay Minnesota taxes and meet eligibility requirements can contribute.

- **How much can I contribute?**

To qualify for the tax credit, contributions must be at least \$1,000 and can't exceed \$2 million each tax year.

- **How much is the credit?**

You may be eligible for a state tax credit of 85% of your contribution.

- **How do I contribute?**

To contribute to the State Housing Tax Credit Program and Contribution Fund, you will need to fill out an application form (*more info on back side*).

- **What happens to my contribution?**

Contributions will be used to develop and fund affordable housing throughout Minnesota. You can opt for your contribution to be designated to a qualified project built by Twin Cities Habitat for Humanity.

Otherwise, your contribution will go into a general housing fund that can be awarded to cities, federally recognized American Indian tribes, developers, nonprofits, public housing authorities, and more.



## Application deadline

Applications for the 2024 tax year must be submitted before 5pm on December 6, with contributions transferred 30 days after application approval or December 31, whichever is sooner.

## How to direct your contribution to The Heights

1. Start an application to the State Housing Tax Credit Contribution by visiting the State Housing Tax Credit Program and Contribution Fund page found at [mnhousing.gov/shtc-contribution.html](http://mnhousing.gov/shtc-contribution.html)
